APPLICATION for the College of Tourism and Leisure Industry

The admission to the four-semester College of Tourism and Leisure industry in Bad Gleichenberg, runs by the Private "Steirischer Hotelfachschulverein", is subjected to the conditions of the ABGB (Austrian Civil Code). This enrolment agreement must be renewed for each school year. School places are allocated in accordance with statutory requirements or at the discretion of the school authority.

I agree with the house rules for school and boarding houses. You can find the current issue on our homepage www.psbg.at. By signing the contract I, my parents or respectively the parental guardians agree to the regular payment of school fees and other costs. I have been informed about the fees and costs for tuition, subsistence and student hostel. The fees have to be paid in advance monthly (12 instalments, beginning on 1st July) and will be withdrawn from your bank account. A discount of 5% is granted when paying the whole amount until 1st September. A discount of 3% is granted when paying the semester amount in advance - on 1st September and 1st February. Additionally all fines, legal costs, expenses for collecting fees and information must be paid if there are any to the "Steirischer Hotelfachschulverein" or its legal proxy (e.g. lawyer). The fees for tuition, boarding and hostel rental for a term becomes immediately due in full if there is a default of payment. In case of cancellation of the enrolment after 1st September the amount of reservation cannot be refunded.

I accept the effective curriculum and will take part in all the lessons.

Should a student be expelled from the school during the school year or should a student voluntarily withdraw from the school during the school year, the school fees for the entire school year are due for payment. Reimbursement will only be made for the proportional accommodation and board costs. It is not possible to withdraw from the student house during the school year if the student continues the education. The fees for school, board and lodging are to be regarded as an annual fee, therefore, in the event of early graduation from the last year of school due to school reasons, a pro rata refund is not provided. All signatories are jointly and severally liable for the above costs.

The student and parent or rather guardian permit the Privatschulen Bad Gleichenberg (short PSBG) the irrevocable right to use images and videos of, with and about students of the TSBG, which are taken within the school education, in-house or external courses, practical assignments and around the school environment. This material is used mainly for promotional purposes (website, press releases and promotional materials) and school's publications. During the training at the College, two in-school and two out-of-school practical assignments are compulsory. Please note that these school events are not paid for. Furthermore, the privacy policy of our homepage www.psbg.at is taken note of.

All the parties to the contract and signatories agree in case of disputes in this legal matter regardless of the amount involved on the jurisdiction of the district law courts for civil law in Graz (in accordance with § 104 Jurisdiktionsnorm).

All the signatories obligate to give immediate notice to the headmaster if their home address has changed. Otherwise delivery to the previous address regardless of the actual place of residence is legal.
